

Terms of Service for Car Social

Effective Date: January 1, 2025

Welcome to Car Social!

You must be at least 13 years old to use Car Social. If you are under 18, you must have permission from a parent or legal guardian.

2. User Accounts

- You must provide accurate, current information when creating your account.
- You are responsible for maintaining the confidentiality of your account and password.
- You agree not to impersonate others or create accounts on behalf of someone else without permission.

We reserve the right to suspend or terminate accounts that violate these Terms or our community guidelines.

3. Acceptable Use

- Not harass, threaten, or abuse others
- Not post or share illegal, hateful, or explicit content

- You agree to follow all local laws, traffic rules, and event-specific guidelines
- You attend at your own risk

Your use of the App is also governed by our Privacy Policy, which explains how we collect, use, and share your personal data. Please review it carefully.
